What is the CANS?

- A Praed Foundation assessment tool.
- Utilized in 50 states, and across multiple NY State Offices.
- Public and available on the Department of Health (DOH) website.
- A comprehensive assessment tool just for children/adolescents under 18 years old.

Who does CANS effect?

- Children and families who want to receive or are currently receiving OPWDD services.
- If the person is 18 years old, the Coordinated Assessment System (CAS) will be used.
- Adults do not need the CANS completed.




What will CANS do?

- Improve how OPWDD serves children/families.
- Provide better information about the child because its questions are right for children, not adults.
- Provide Care Managers with information to help develop a plan that best supports the child and family.



What is the assessment process?



Coordinated Assessment System (CAS): Update

- Over 80,000 assessments completed statewide
- Assessments continue to be completed for all adults:
 - Living in any residential setting
 - Living at home or independently receiving any service from OPWDD
 - Self-directing with budget authority
 - Newly determined eligible adults (18 and older)



Recent Updates to CAS Process

- Telehealth option for virtual in-person assessment interviews
- Collaboration with DDRO Front Door and CCO to identify priority assessments
- IT solutions for efficiency with scheduling and completion of assessment process



OPWDD Quality Assurance

- OPWDD completes a quality assurance sample review of all assessors, on an ongoing basis
- OPWDD Quality Assurance activities:
 - Surveys
 - Cross item consistency
 - QA review of CAS summary concerns
 - Field observations
- Individual guidance and training is reinforced with assessors (of both workforces), based on quality reviews




